



Charles A. (Chuck) Thompson

1934 - 2019

Charles A. Thompson, long time member and supporter of *REACT*, passed away on March 13, 2019.

"Chuck" as he was known to friends was born on August 8, 1934. He was married to Judy.

They had 5 children, Patricia, Robert, Richard, Ronald and Edward plus 9 grandchildren and 10 great-grandchildren.

He was a veteran of the US Army. In 1955, Chuck received his commission as a 2nd

Lieutenant in the US Army. During his regular army career, he served in the Strategic Air Command at Ellsworth Air Force Base in South Dakota and was an officer in the Redstone Rocket Program in West Germany during the Cold War. While stationed at Fort Hood, Texas he was deployed with the 1st Armored Division to Georgia during the Cuban Missile Crisis. He retired from active duty in 1963 holding the rank of Captain.

He was educated and trained as an attorney and was an Assistant Dean and Assistant Professor at the Southern Methodist School of Law from 1966-69.

He joined Dallas County *REACT* in April of 1978 and was granted a Life Membership of *REACT* International on July 20, 1983.

Chuck served in many Team offices, including Team President in 1979 then from 1985-1999 and again from 2011-2014. He was Secretary and Treasurer or Ass't Treas-

surer from 1984-2014.

He was Executive Vice President of the Texas State *REACT* Council in 1982.

He was Chairman of the Board of Dallas County *REACT* from 1980-81.

Chuck was very active in *REACT* International, also. He served as V. President and General Counsel of *REACT* International from 1998 - 2001.

He was elected President of *REACT* International in 2001 and served in that office until 2004.

In 2004 until 2012, Chuck served in the office of *REACT* International General Counsel. He served for a short time as Secretary of the corporation in 2013.

Chuck was laid to rest with Military honors at the Dallas - Ft. Worth National Cemetery in Dallas, TX on March 25th, 2019.

The Year of The Pig.

This was the theme in Las Vegas, while attending the February, 2019 annual winter board meeting. This marked the Chinese New Year, or spring festival, that marks the end of the coldest days. We welcome spring and all that comes with it; planting, harvests, fresh starts and new beginning's.

The spring festival, originally a ceremonial day to pray to the Gods for a good planting and harvest season. As an agrarian society, people also prayed to their ancestors, as they were treated as Gods, but the myths were more interesting. One legend noted a monster named Nian that made everyone hide in their homes. One little boy was brave enough to fight him off by using firecrackers to scare him away. The next day people celebrated their survival by setting off even more firecrackers that became a crucial practice during every spring festival.

Gifts are exchanged during the spring festival, sometimes including lucky money in red envelopes to transfer the elders fortune to their children, but may be given between bosses and employees, co-workers and friends. Some of the taboo behaviors include saying words with a negative connotations, like death, sick, empty, poor, break, kill and to avoid fighting, ending things peacefully and so on. This is mostly not to jinx oneself or invite bad karma into your life. The feast day of Easter was originally a pagan celebration of renewal and rebirth. Celebrated in the early spring, the resurrection symbolizes the eternal life that is granted to all who believe.



REACT International, its members, Teams and Councils who believe in our program are similarly celebrating our spring festival with the election of new officers and Directors to serve the membership. As REACT members, teams and councils start the New Year, we seek ways to improve our skills, improve our proficiency or increase our activities in public service events or monitoring, we can certainly benefit from some of those practices noted above because we are a nonprofit.

A nonprofit organization is supposed to exist as a legal entity in its own right and separately from its founder(s). Incorporation puts the nonprofit's mission and structure above the personal interests of individuals associated with it. A nonprofit is dedicated to the public interest; therefore, its finances are supposed to be open to the public for inspection. The public may obtain copies of a nonprofit organization's state and Federal filings to learn about salaries and other expenditures a nonprofit is doing with donations.



Under the law, creditors and courts are limited to the assets of the nonprofit organization. The founders, directors, members, and employees are not personally liable for the nonprofit's debts. However, there are exceptions. A person cannot use the corporation to shield illegal or irresponsible acts on his/her part. Also, directors have a fiduciary responsibility; if they do not perform their jobs in the nonprofit's best interests, and the nonprofit is harmed, they can be held liable.

One of the fine lines of the past is not to dwell on our less favorable, adverse history, but to celebrate our significant changes in the growth and development of

REACT International that all started during a cold winter Blizzard in January, 1962. *REACT* petitioned the FCC to designate a CB radio emergency channel that took three years to accomplish. The awarding of our nonprofit status, signing of agreements with national disaster response teams and special interests groups, launching our highway safety break program in the seventies are many of the things we have accomplished.



I know, what does all this have to do with *REACT*? Personally, this was my first time traveling west of the Mississippi River from Boston. It was certainly an experience to remember. Las Vegas was certainly a fantastic place to visit. I think our predecessors envi-

sioned the winter board meeting as our own spring festival to start each New Year with the best effort we can. I realize we as a whole have endured some pretty



crazy stuff that you may only read about in a novel, but by practicing and promoting the best of our ability to help our community. We can remember our dark past, go around



with a chip on our shoulder and dwell on it, inviting more negative energy and karma or honor our *REACT* predecessors by finding ways to keep our program, not only alive and well, but one sought after by many radio operators who want to escape the bad ju-ju of the world.

Finally, I have to hit upon the irony of communications between the membership, Teams and councils with the *REACT* International Directors, office staff and volunteers.



We, the Directors, office staff and volunteers can't possibly support you or support your Team by not knowing what you do or how you do it. Another Team may be able to learn from your best practices instead of re-inventing the wheel, or your Team may be able to solve and learn from another Team's Best Practices. Whether we satisfy our 501(C)3 purpose with Education, Auxiliary Communication Service, Public Service Events or other community relief efforts, we are communicators who need to communicate with each other to make all of us, the *REACT* program, the best we can be.

Recently, we went to Big Bear with a group of 4 wheelers and had fun in the snow. It was icy in spots so even with four wheel drive and off road tires, people were sliding all over the place.

All in all we had a great time. At the end of the run, we all went our separate ways and we decided to head back to San Diego while a few others camped out at the campsite. Unfortunately we got a bit lost and were told by a guy from our group to take this trail to the main highway but it was iced over and three of the members of the group almost slid off a cliff and warned us not to go that way.



A few other trails were iced up or locked by a gate. Our option was sleep in the back of my truck for the

night with a few other folks for the snow run. I had blankets, food and water, first aid kit etc., so it was not a big deal to do that but our preference was to head for home. I decided to get on the ham radio (living in Southern California I have over 100 repeaters programmed into my radio.) I can communicate all over So Cal, including Big Bear. I got on the repeater and asked if anyone was monitoring.



I got several call-backs and I told them if they could direct us to Hwy 18. (Since we were in the mountains, we had no GPS that was working and no cell service.) One ham operator even offered to open a gate for us since he had a key. The operator, named Kevin, (I forgot his call sign) was at home, he looked at his map and told us which trail to take to Hwy 18. He told us certain landmarks to look for and he said he would monitor the frequency until we made it to the highway. Kevin said the trail would be icy and to go slow and yes it was hairy at

times, about 4 inches from a cliff drop off.

Kevin even offered to come out in his truck if needed. After 45 minutes, we got to Hwy 18, keeping in touch with Kevin along the way. I thanked him countless times on the air and others for their assistance.

The “moral of the story” is that I’m proud to be a licensed Amateur Radio Operator and it’s times like this that ham radio comes to the rescue when all else fails. Before you head into the back country, consider getting licensed and your ham radio, because it can save you. Don’t rely on GPS or cell. They are worthless in these situations. I sent a message to the Big Bear Amateur Radio Club, acknowledging Kevin’s assistance.

(North Carolina)



Director Jenkins moved to accept the agenda, second by Director Goswami.

6) APPROVAL OF MINUTES FOR;

* 08/26/2018 – Special Meeting Minutes: Director Mahon moved to approve the minutes from August 26, 2018, second by Director Jenkins. The motion passed unanimously. (R1- Yes R6-Yes R7-Yes R8-Yes R9-Yes)

7) NEW BUSINESS

* Membership Report

It was noted that renewals are a little over 50%, so we are doing fine. Director Jones questioned if the percentage reported was accurate. Treasurer Richards clarified that the math is correct based on the data available as of 02-FEB-19.

* Financial Report:

The FY 2019 report was presented and noted to be based on 100 percent renewal based on the current numbers of each membership class. We should have a better report by the next meeting after the close of renewals.

* The Office Review Report: was submitted by Director Mahon, discussed and acknowledged that no action is required at this time.

* Rojas CPA Letter (Not Received)

The letter was not received by the CPA for review.

* Life Member Patch

Will Stanley submitted a life member patch for consideration to *REACT* International with the intention of seeking designs from the life membership if they want to contribute. A new Life member patch should be consistent with the new *REACT* International logo. The Life membership chairman head the effort.

* Training PowerPoint Presentation:

Walter Green submitted a ready team proposal to address the potential request for assistance for AuxComm resources from one of our National partners with which we have a memorandum of understanding (MOU) with. A presentation was review but without the benefit of Mr. Green's guidance due to the lack of available bandwidth for the call.

* Directors Reports:

The submitted reports from our Region Directors are on file.

* International Dues Freeze

Proposed by Director Mahon: Where the US dollar index is the global standard for economies and currency exchange rates. This means International team members are currently paying higher rates than US & Canadian based teams, due to the exchange rates. An International dues freeze was proposed to ease the financial burden on international members, until the US dollar index drops to 85-86%. Such a drop would devalue the US dollar to insufficient levels where *REACT* International would not be able to support international membership at what would become a weaker dollar and reduced exchange rate.

Director Jenkins moved to accept the international dues freeze, second by Director Goswami. The Motion passed unanimously (R1-Yes R6-Yes R7-Yes R8-Yes R9-Yes)

* Policy 1-03

New Policy 1-03 to be created and presented by Director Mahon. Establishing repercussions for all classes of membership and teams that do not register or re-register the corporate interoperability agreement. This could be a removal of members of teams or teams in general for unauthorized use of the corporate frequencies. There have been a few occurrences of unauthorized use that have made such a need to protect the organization. It was noted the use is limited simplex use only, no setting up shop with permanent radio infrastructures and such.

Director Mahon moved to create policy 1-03, second by Director Jenkins. The motion passed unanimously (R1-Yes R6-Yes R7-Yes R8-Yes R9-Yes).

* Policy 5-03

This policy proposal was regarding Repercussions of Directors abusing bylaws section 5.5 regarding self-resignation after missing 3 meetings of the Board of Directors. It was decided that this would be best if sent to the Bylaws committee. There were no objections, and so moved.

* Honorary Membership

Presented by Director Goswami, we need to define what an Honorary Membership is because it reads that any team can have a member, group, team that is Honorary. Region 9 Robby Goswami talked about how the topic came up and how it is for non-active *REACT* members and those people do not pay dues to the organization. It was unclear if this had been given to any individual before. *REACT* International's founder, Henry B. (Pete) Kreer's wife is still alive, and we should offer her an Honorary Membership. Two things appear on who can be awarded the Honorary Membership. i.e. Mayor, Fire Chief, etc. A document on how and who can be assigned an Honorary Member.

Director Goswami moved, seconded by Director Jones, to extend an Honorary Membership to Mrs. Kreer. R1 Yes, R6 Yes, R7 Yes, R8 Yes, R9 Yes: Motion Passed.

* 2019 Budget

President Capodanno reviewed expenses, income, and other line items on the budget report. This report is extensive with active, inactive, regular, family members, junior, etc. These numbers won't be concrete until the end of the year when we can flip the numbers.

We are running upside down right now, but with generous donations, we are still operating. President Capodanno will try to get a monthly report out if possible. ITC was clarified to be for technology expenses. This number is a budget and not a concrete expense.

Director Mahon inquired about the replacement of aging technology. President Capodanno said we need to update the new smaller computers and thus will have a more efficient membership ID printer. The printer needed some maintenance and he decided it was more cost effect to clean it and when the time comes we will purchase a new machine.

Director Mahon moved to approve 2019 Budget, seconded by Director Goswami. The motion passed unanimously (R1 Yes, R6 Yes, R7 Yes, R8 Yes, R9 Yes)

* State filing listing by state

We now have an updated spreadsheet of Secretary of State annual filings for teams, limited to those states we are currently active in. The remainder of states will be added later.

William Richards briefed the Board of Directors of the progress highlighting the capabilities we are seeking to assist the office staff and volunteers with information updates and renewals.

The Chairman opened the floor for nominations for secretary. Director Jones nominated Mr. Richards. There were no further nominations and Mr. Richards was elected unanimously.

The Chairman opened the floor for nominations for treasurer. Director Jenkins nominated Mr. Dunn, Director Mahon nominated Mr. Misetich. There were no further nominations and Mr. Misetich was elected.

The Chairman opened the floor for nominations for vice chairman. Director Jones nominated Mr. Goswami. There were no further nominations and Mr. Goswami was reelected unanimously.

Director Tom Jenkins was recognized for his work contacting all the life members to confirm and update their demographics. A job well done!

Well, it's starting to get warmer and the spring flowers are popping up but nights are still cold. Soon it will be hot and we will be thinking of this cool/cold weather.

GMRS is a great means of communications, no test required you pay \$70.00 for a 10 year license and you can use all the open repeaters in the United States. The way the license structure is set up to be legal each member of the *REACT* team will have to purchase a GMRS license, but it is good for the family.

If three of the team members are related, just one license is required to cover those three family members. You use the same given call letters and you can differentiate by adding R numbers after the call letters.

There is talk about that GMRS license will be totally free in the near future, but things can change. It is not that hard for a team to

set up their own GMRS repeater. You can go to www.gmrs.com and find a plethora of information on that website. Remember, its all about antenna height and not just power output. The antenna makes the radio.

If you would like more info on GMRS repeaters or communication in general drop me an email; I will be happy to talk with you.

In closing, once again, to get your amateur radio license. There are only 35 questions on the test, it's easy and free. Go to YouTube.com. Do a search for ham whisperer and study the free online test. Then, when you feel confident in your proficiency, find a ham radio group near you and find out when they give the test.
